Designated terrorist Landa's brother extradited from the UAE, arrested

CHANDIGARH, AUGUST 9

THE NATIONAL Investigation Agency (NIA) Friday arrested Babbar Khalistan International terrorist Tarsem Singh, who was wanted in connection with an RPG attack on the Intelligence Headquarters of the Punjab Police in Mohali and other terror cases, officials said.

Tarsem, facing an Interpol Red Corner Notice, was arrested from IGI airport in Delhi after he was extradited from Abu Dhabi. He is the younger brother of Canada-based designated Khalistani terrorist Lakhbir Singh Sandhu, alias Landa.

A native of Punjab's Tarn Taran district, Tarsem is a key member of the BKI and an important terror node of Landa and another designated terrorist Harvinder Singh, alias Rinda in the UAE, an NIA spokesper-

son said.

"He was initially picked up in Abu Dhabi in November 2023 following the issuance of a non-bailable warrant by an NIA special court and the subsequent Red Corner Notice by the Interpol. Eventually, he was extradited from the UAE to India in adherence to Interpol's due processes," the spokesperson said.

"Probe has revealed that Tarsem was actively involved in arranging and providing terror

funds to India-based associates of Rinda and Landa. He was also involved in the channelisation of terror funds through multiple routes," the spokesperson added.

The NIA had suo motu registered the case on August 20, 2022. The case relates to terror activities of chiefs/members of proscribed terrorist organisations, such as Khalistan Liberation Force (KLF), BKI, International Sikh Youth Federation (ISYF) etc, who have established a massive network of terror operators across India.

"These outfits are working through operatives/members of terror outfits and organised criminal gangs to smuggle arms, ammunition, explosives, IEDs from across the border. They have been using, narcotics trafficking, extortions, hawala trading to generate funds for carrying out terrorist activities on Indian soil. NIA investigations so far have revealed," the spokesperson added.

Border dispute: Assam, Mizoram ministers meet after two years

Delegations led by ministers of Mizoram and Assam met in Aizawl Friday evening to discuss the inter-state boundary dispute between the two states. It was the first such meeting since the new Zoram People's Movement came to power in Mizoram.

The last high-level meeting on this issue had been held nearly two years ago in November 2022 in Guwahati, when Zoramthanga's Mizo National Front was in power in Mizoram. The two states share a 165-km boundary that runs along Cachar, Karimganj and Hailakandi districts on the Assam side, and Mamit, Kolasib and Aizawl districts on the Mizoram side.

The long-standing dispute turned violent in 2021 when six Assam police personnel were killed in a clash at the border. On Friday, the Assam government delegation led by Border Protection and Development Minister Atul Bora travelled to Aizawl and met the Mizoram delegation led by Home Minister K Sapdanga.

In Manipur, gunfight claims three lives

THREE PEOPLE were killed in a gunfight between armed Kuki-Zo 'village volunteers' and members of a Kuki insurgent group in Manipur's Tengnoupal district Friday morning, *The Indian Express* has learnt.

The gunfight took place in the Pallel region in Manipur's Tengnoupal district, around 45 kilometres from state capital Imphal, where the state legislative assembly was in session.

According to the Manipur police, however, as of Friday night, no bodies had been recovered from the site.

SP Tengnoupal Rahul Gupta said police went to the site around 9:30 am Friday morning after they received reports of a gunfight in the area and found that a house had been burnt down. Teams comprising police, Assam Rifles and the Border Security Force were conducting searches in the area but had not recovered any bodies as of 10:00 pm, he said.

Meanwhile, security sources

claim the gunfight began after the armed Kuki villagers attacked the United Kuki Liberation Front (UKLF) — one of the groups under the umbrella United People's Front, a signatory in the tripartite Suspension of Operation agreement between Kuki insurgent groups and the state and central governments — in the area.

There were internal tensions between the parties over control over 'taxation' and control over trade routes in the area, the sources said, adding that of the three fatalities, two were armed villagers and one was from UKLF cadre, while the burnt house belonged to UKLF chief SS Haokip.

An unconfirmed statement — purportedly by the UKLF — also claimed that the insurgent group had been attacked by members from the same community in Pallel. It alleged that the attackers were "collaborating with Meiteis".

This incident comes at a time when violence between Meiteis and Kukis has come down, with the last major flare up being in Jiribam in June.
