# Booked under POCSO for 'kidnapping' student, Surat woman undergoes abortion

## Foetus samples preserved for DNA test; teen undergoing counselling for trauma: Officers

FOLLOWING COURT'S permission, a 23-year-old woman, accused of kidnapping and wrongful confinement of a 13-year-old student, underwent the procedure for termination of her 22-week pregnancy at a hospital in Surat on Thursday, police said.

Samples of the foetus have been preserved and sent for tests to determine paternity, they added.

The woman was brought to the hospital from the Central Jail where she is in judicial custody after she was booked under sections 137(2) (kidnapping) and 127(3) (Punishment for wrongful confinement) of the Bharatiya Nyaya Sanhita (BNS), besides under the POCSO (Protection of

Children from Sexual Offences) Act, on April 26.

The woman was nabbed and the boy rescued from Shamlaji on the Gujarat-Rajasthan border on April 29.

The boy is undergoing counselling as he is "under trauma", sources told *The Indian Express*.

On Tuesday, Surat Special POCSO Court of Judge R R Bhatt passed an order granting the application for Medical Termination of Pregnancy (MTP) filed by the teacher.

Acting on the orders of the court, Punagam police took custody of the accused teacher from Surat Central Jail on Wednesday. She was brought to the hospital where she underwent primary examination and later, a team of surgeons from the Obstetrics and Gynaecology department carried out the procedure on her.

Sources said the teacher's condition is stable but due to weakness caused by heavy blood loss, she will be kept at the hospital for a few more days.

Talking to *The Indian Express*, Punagam police inspector V M Desai said, "The foetus had been preserved and samples had been taken from it, which have been sent for DNA test at Forensic Science Laboratory (FSL). Through a DNA test, we would know who the father is. Once we get the report from FSL, we will submit it to the Special POCSO court in the coming days...Once she (the teacher) becomes physically fit, we will drop her back at Surat Central jail. A police team has been deployed at the ward where she is admitted, so that she does not escape."

Desai further said, "We have got the boy counselled by a psychiatrist for five days, as he was also under mental trauma. Now his condition is reported to be stable."

The FIR in the case was registered against the teacher on April 26, after the woman and the boy went missing on April 25 and the teenager's father lodged a complaint at Punagam police station.

After they were found on April 29, the teacher underwent a medical examination and has since been lodged at the Surat Central Jail.

Defence lawyer Wajid Shaikh had, on Friday, applied to the Special POCSO court seeking permission for abortion under the MTP Act's section 3. The application stated that the physical condition of the accused is weak.

# 100 children avail free replacement of hearing devices, many await turn

MONTHS AFTER the Gujarat government told the state legislature that it would provide one-time replacement for hearing devices for free to children under the School Health Programme, in August 2024, 100 children on Thursday availed the benefit. Several others who have registered, however, are awaiting their turn.

The government had allocated Rs 35 crore for the replacement process. Children who had received cochlear implants under the government policy, but have had the speech processor broken or damaged, will be covered. A government statement said that the state has identified 1,365 children who required replacement of cochlear implant processor kits. Of them, 700 children have to get it done this year.

Health Minister Rushikesh Patel announced

the decision in the Gujarat Legislative Assembly.

On Thursday, while the first cohort of 100 children needing replacement of cochlear implants and external speech processor machines were provided the same at GMERS Sola Civil Hospital in Ahmedabad, another 220 children will be covered in the next tranche.

Speaking at the event, Minister Patel said, "The government will not let a child's education stop and their future dimmed due to hearing loss or the breakdown of a machine. And that is why it has decided on a one-time replacement for free..."

He added, "If the machine was originally implanted at a private hospital, a nominal amount of 10 per cent of the total cost will be charged and the machine will be replaced."

Notably, the policy of the government will require patients to visit either Ahmedabad Civil Hospital or GMERS Sola MCH, both in

Ahmedabad, to apply for replacement of the processor as only these two hospitals have audiology colleges.

Now nine-year-old, Rashi Talreja got a unilateral cochlear implant in 2016 at Ahmedabad Civil Hospital when she was just 18-month-old. Her mother Bhoomi told *The Indian Express*, "Like every gadget, speech processor also requires maintenance, but the costs are very high. While it's not possible to afford a new machine, which costs Rs 5 lakh, we have been having this one repaired and refurbished over the years." Rashi has registered for a replacement and is awaiting a call.

Dr Rajesh Vishwakarma, Director and Head of ENT and Head and Neck Surgery at Apollo Hospital, Ahmedabad, and one of the pioneers of cochlear implants surgeries in India, said: "The families of several patients who cannot afford a repair or replacement decide to just forego it."
